Шенгенская виза — это документ в виде принта-наклейки в загранпаспорте. Он даёт туристу право посещать страны **Шенгенской** зоны, в которую входит 26 европейских государств, кроме Великобритании. Наличие шенгенской визы разрешает россиянам пересекать границу и передвигаться по странам Европы, где действует Шенгенское соглашение. С данной визой можно путешествовать в страны, заключившие соглашение, несколько раз за весь период и находиться в них максимум 90 дней. Каждые полгода, пока действует виза, 90-дневный срок обнуляется. Многие считают, что страны Шенгенского соглашения – это вся территория Евросоюза. Но это неверно.
